 - Proposed Project Team (Implementation team must have a Certified Lead Implementor and a Certified Lead Auditor)
 - No JV or subcontract is allowed for this project.
- 3. The bidder should have experience in designing, developing, implementing, and successful certification assistance in ISO 27001:2013.
- 4. Bidder must Provide at least 10 Implementation work orders/PO's for ISO 27001 in last years.
- 5. The bidder must have offices in Pakistan specially Karachi where the project is to be executed.
- 6. The bidder lead auditor must have at least 10+ years of ISO 27001 consulting experience.
- 7. CV of the lead auditor along with relevant ISO 27001 certifications to be provided proving 10 years of experience
- 8. The bidder have at least 1 Certified Lead Implementor and 1 ISO Lead Auditors in the organization as permanent employees.
- 9. Certificates to be attached with the bid
- 10. The bidder must have performed at least 10 ISO 27001 Certification assignments in Pakistan.
- 11. ISO 27001 Certification work orders/PO's to be provided
- 12. High Level Project Plan

- 13. Pricing for the service to be provided
- 14. Details of the persons who will be designated to perform the required services *(fieldwork)* which should comprise of the following:
 - Relevant experience, qualification and certifications
 - List of clients on which the designated person performed similar nature of projects along with client contact name, email address and a contact phone number.
